

Evaluation of the results of education of students of Sunny Canadian International School – Elementary and High School, s.r.o. in the second semester of the school year 2019/2020

Based on the Resolution of the Government of the Czech Republic of 12 March 2020 No. 201 (promulgated under No. 74/2020 Coll.), and the subsequent precautionary measure of the Ministry of Health 16184 / 2020–1 / MIN / KAN of 15 April 2020, with which the personal presence of students and students in elementary, secondary and higher vocational education, in basic artistic education, language education and hobby education unchanged as in Government Resolution No. 201 of 12 March 2020, promulgated under No. 74, was prohibited / 2020 Coll., with which the government banned the personal presence of students in schools and school facilities, the Elementary and High school SCIS replaced on-site teaching with the form of online distance education from 12 March 2020.

The final assessment of the student on a report card at the end of the second semester of the 2019/2020 school year will therefore take into account that due to unforeseen events it wasn't possible to fully fulfill the School education plan for that school year and cannot follow the same criteria as, for example, last school year.

Based on Decree 211/2020 Coll. of 27 April 2020 regarding the evaluation of the results of students' education in the second half of the school year 2019/2020, and pursuant to Sections 56, 71 and 112 of Act No. 561/2004 Coll., regarding pre-school, elementary, secondary, higher vocational and other education (school law) I therefore stipulate:

A) Rules regarding student evaluation for second semester of school year 2019/2020

(1) In basic education and in secondary education, the evaluation of the students' educational results for the second semester of school year 2019/2020 is based

- a) on the evaluation materials obtained in the second semester at the time when the pupil was obliged to attend school properly, i.e. from 20 January 2019 to 10 March 2020,
- b) additionally on the assessment materials obtained during distance education, if the student has the conditions for such education,
- b) additionally on the assessment materials obtained during educational activities carried out in school, during times the student is not mandated to attend
- c) additionally on evaluation of the student from first semester of school year 2019/2020.

(2) Rules in the school regulations or rules for the evaluation of students' learning outcomes approved by the school board which are in conflict with paragraph 1, or which do not allow the assessment of students for the second semester of the 2019/2020 school year under paragraph 1, shall not apply.

3. Assessment during distance learning or during educational activities in the form of school groups or in another form until the end of the second semester must not be a reason for grading a student on a report card for the second semester of the 2019/2020 school year with unsatisfactory or equally worded grade.

4. The lack of materials for evaluation for the period from 11 March 2020, i.e. for the period of distance education during school closures or during educational activities in the form of school groups or in another form until the end of the second semester, is not in itself a reason for a student to be marked „not graded“ rather than graded.

5. Only hours missed before the beginning of the ban on the personal presence of students in school education, i.e. from 20 January 2019 to 10 March 2020, are counted as missed classes.

B) Exams and commission examinations

(1) If an examination or commission examination stipulated by legal regulations or an examination resulting from an individual educational plan is held for the assessment of a student, their holding and the assessment of the student on the basis of them are not affected by this Decree.

C) Final report of 4th grade of SCIS High School, who applied for 2020 spring graduation

(1) A student of the SCIS High School who has applied for the graduation exam for the spring probationary period of 2020 cannot be assessed with a grade of “5 - insufficient” or with the words “not evaluated” or an equivalent verbal evaluation for the second half of the school year 2019/2020; instead, the word "passed" or another equivalent verbal assessment shall be given for individual subjects or the overall assessment.

D) Final statements

(1) The rules of evaluation are posted on the school website.

(2) The publication of the results of the school system Škola Online is considered to be a demonstrable acquaintanceship of the student with the results of the continuous assessment for the second half of the school year 2019/2020.

(3) The classification order for the assessment of students for the school year 2019/2020 remain in effect. However, for the evaluation of students for the second semester of the school year, this decision shall apply with priority.

(4) The decision came into effect on 28 April 2020 and has been noted to the School Board.
